President Santa Attends AFL-CIO Executive Council Meeting



President Santa Attends AFL-CIO Executive Council Meeting

Washington | February 2023

NATCA President Rich Santa attended the AFL-CIO's Executive Council meeting in Washington on Feb. 7-8. The Executive Council is made up of the AFL-CIO's President, Secretary-Treasurer, and 55 vice presidents, including Santa, who was elected as a vice president to the council in 2022. This most recent meeting focused on key AFL-CIO initiatives including legislation and policy priorities in the 118th Congress, maximizing the effectiveness of our labor movement's grassroots infrastructure, and organizing strategies. Congressman Hakeem Jeffries joined the council for discussion about the labor movement's legislative priorities.
